## Permit Requirements

1. Signed application from the company employing the driver.
2. Record check through the Oklahoma State Bureau of Investigation (OSBI) no more than 30 days before applying for the driver's permit. The OSBI background information includes a check of the sex offender registry, violent offender registry and criminal background.  
**OSBI**, 6600 N Harvey Place (west of N Broadway Extension and north of NW 63) • 405-848-6724
3. Physical completed no more than 30 days before application date. A driver medical certification form (provided by the Vehicle for Hire Inspector) must be completed and accompany the application.
4. Copy of the applicant's three-year driving record, issued by the Oklahoma Department of Public Safety or Oklahoma tag agency, obtained no more than 30 days prior to application date.
5. Two forms of identification  
**Accepted identification:** passport, work visa, Oklahoma driver's license, social security card, firearm/handgun permit issued by a state agency, fishing/hunting license, health insurance card, current student ID, state certified birth certificate, U.S. military ID, veteran's ID or government issued photo ID card.
6. U.S. Lawful Presence Affidavit (new permits only) showing current citizenship status. You must be a U.S. citizen or legal alien to receive a driver's permit.
