Permit Requirements

- Signed application from the company employing the driver.
- Record check through the Oklahoma State Bureau of Investigation (OSBI) no more than 30 days before applying for the driver's permit. The OSBI background information includes a check of the sex offender registry, violent offender registry and criminal background.
OSBI, 6600 N Harvey Place (west of N Broadway Extension and north of NW 63) • 405-848-6724
- Physical completed no more than 30 days before application date. A driver medical certification form (provided by the Vehicle for Hire Inspector) must be completed and accompany the application.
- Copy of the applicant's three-year driving record, issued by the Oklahoma Department of Public Safety or Oklahoma tag agency, obtained no more than 30 days prior to application date.
- Two forms of identification
Accepted identification: passport, work visa, Oklahoma driver's license, social security card, firearm/handgun permit issued by a state agency, fishing/hunting license, health insurance card, current student ID, state certified birth certificate, U.S. military ID, veteran's ID or government issued photo ID card.
- U.S. Lawful Presence Affidavit (new permits only) showing current citizenship status. You must be a U.S. citizen or legal alien to receive a driver's permit.
