Location SW 29th Street and South Santa Fe Avenue

Background This 2007 General Obligation Bond Authorization, Proposition No. 4,

Section A.2 project provides for drainage improvements, mapping and equipment which may include related right of way acquisition, engineering, utility relocation, maintenance access ways, and/or landscaping along with repair and/or construction of related sidewalk.

This project will begin in September 2015 with an estimated completion of spring 2016.
