ORDINANCE NO. _____.

AN ORDINANCE RELATING TO THE GENERAL SCHEDULE OF FEES; AMENDING CHAPTER 60, ARTICLE IV, SECTION 60-38-11 OF THE OKLAHOMA CITY MUNICIPAL CODE, 2010, ADMISSION FEES FOR ENTRY TO CITY SWIMMING POOLS; SECTION 60-38-12, FEES FOR USE OF CITY POOL PARTY AREAS; SECTION 60-38-17, FEES FOR OTHER PERMITS AND RESERVATIONS; AND SECTION 60-38-22, FEES FOR CONCESSION OR TICKET SALES ON CITY PROPERTY, EXCLUDING REGATTA PARK AND ZONE M.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

SECTION 1. That Sections 60-38-11, 60-38-12, 60-38-17, and 60-38-22 of Article IV, of Chapter 60 of the Oklahoma City Municipal Code, 2010, are hereby amended to read as follows:

§ 60-38-11. Admission fees for entry to City swimming pools.

All applicable taxes included.

(a) single admission*:

swimming pool.....	Free
specialty pools (Woodson Park and Northeast Pools).	Free
Earlywine Family Aquatic Center and Will Rogers Family Aquatic Center.....	<u>\$6.00 48" in height and under, \$6.00; over 48" in height, \$7.00.</u>

*Admission for organized groups of 20 or more is by reservation only.

A credit voucher, for a single admission, will be given to each participant if asked to leave a Family Aquatic Center due to maintenance problems or inclement weather conditions. Refunds will not be given for single or group admissions.

The Director of the Parks and Recreation Department has the authority to set temporary pool admission prices for special promotions.

§ 60-38-12. Fees for use of City pool party areas.

All applicable taxes included.

Party areas at Earlywine and Will
Rogers Family Aquatic Centers,
during operating hours*, per hour...

50.00 for large party areas.

*The fee shall be charged in one-hour increments, with a minimum of two hours. Individuals using the party areas are required to pay all applicable admission fees.

§ 60-38-17. Fees for other permits and reservations.

All applicable taxes included per permit.

permit fee, per day (consecutive days), per park	80.00

*A staff fee will be charged when special events activities require a staff person's presence, such as securing a facility after the posted hours of operation.

A \$20.00 key deposit fee is required for all applicable facilities. Key deposits will be refunded, provided keys are picked up prior to the event and returned within three working days of the use.

Earlywine Tennis Center and Oklahoma City
Tennis Center):

*Purchase of a season permit entitles the permittee to use a field or tennis court for 90 consecutive days, a maximum of six hours per week, spread over no more than three days per week. Use of a field or court in excess of six hours per week will be granted at no additional charge if such use does not conflict with prior reservations.

**Purchase of a two-hour permit entitles the permittee to use a field or tennis court for a maximum of two consecutive hours. Multiple permits may be purchased in two-hour increments.

***The fee shall be charged in one-hour increments with a minimum fee of three hours.

****A security deposit is required for all non-athletic stadium rentals. The security deposit will be refunded, provided no damage is inflicted on the facility and no equipment is lost or damaged, and the stadium is left clean and in such condition as to allow activities to continue as scheduled. No refund will be given for athletic events due to inclement weather or other situations beyond the control of the Parks and Recreation Department.

A \$20.00 key deposit fee is required for all applicable fields and stadiums. Key deposits will be refunded provided keys are picked up prior to the event and returned within three working days of the use.

§ 60-38-22. Fees for concession or ticket sales on City property, excluding Regatta Park and Zone M.

All applicable taxes included per permit.

(a) for-profit organizations, per day, per point of sale	\$150.00
(b) nonprofit organizations, per day, per point of sale	100.00
(a) 2-10 points of sale, per day...	\$50.00*
11-24 points of sale, per day...	100.00

*1 point of sale fee included in the cost of the parks special event permit.

~~Nonprofit organization means any organization or corporation organized under state and federal laws as a nonprofit or corporation and authorized to function in this State as a nonprofit organization or corporation.~~

~~Cancellations—If a cancellation notice is received in the Parks Administration office at least seven calendar days before the scheduled event, an alternate date, within six months, may be chosen. If no notice of cancellation is given, no refund will be given. If a cancellation is received in writing by the Parks and Recreation Department at least 21 calendar days before the scheduled event, an alternate date, within six months, may be chosen, or the permittee may request a full refund of any associated fees. If a cancellation notice is received in writing by the Parks and Recreation Department at least 15 to 20 calendar days before the scheduled event, an alternate date, within six months, may be chosen, or the permittee may request a 50% refund of any associated fees. If notification of cancellation is given 14 calendar days or less before the scheduled event, no alternate date or refund will be given.~~

If weather conditions (inclement weather) prohibit the use of a reserved area, resulting in no concession and/or ticket sales, an alternate date can be selected at no additional charge.


