Reference attached Sample. The instrument vacating the plat, or a portion of a plat, must contain the signatures of all property owners within the plat if the entire plat or a street within the plat is to be vacated. If only a portion of a plat is to be vacated, and that portion does not include street right-of-way, the petition must consist of the owners of 60% of the lots within the plat. One (1) copy of a Survey plan of the Plat, or Partial Plat area, to be vacated in a PDF (.pdf) file format. Three (3) copies of abstractors verification of all property owners within the subject plat. The ownership list must be dated within 10 days of date of filing the plat vacation application and contain names, mailing address, and legal description of the owner's property. ☐ Maps, Site Plan and, or Survey Exhibits must be Letter size (8.5" x 11"), 600dpi minimum resolution, and in a .pdf file format.
