Building projects in the City's design review districts require a Certificate of Approval prior to obtaining a building permit. Work on approved projects may not commence until after the mandatory 10-business day appeal period starting from the date of approval. BCA-25-00001 at 229 E Sheridan Avenue (Bricktown). Application by Brittany Lander, Metro Sign, for Brian McNabb, The Bridge Venue, Inc, to: 1) Remove existing attached wall sign from the south elevation; and 2) Install new attached wall sign (with logo) at the south elevation.

DTCA-24-00040 (R1) at 31 NW 14th Street (DTD-1). Application by Mark Zitzow, Aicp, Johnson & Associates, for Candace Baitz, OperationReadyMix, LLC, to: Demolish curb, construct new curb and install angled on-street parking spaces.

UDCA-23-00030 (R2) at 2500 S Harvey Avenue (Capitol Hill). Application by Shannon Entz, City of Oklahoma City Planning Department, for Debbie Miller, City of Oklahoma City Public Works Department, to: 1) Revise the paver pattern to the left and right of the "Historic Capitol Hill" paver signs at the north and south ends of the site; 2) Construct a "Ribbon Banner" structure with string lights as the Plaza Canopy; 3) Remove affected wheel stops in the church parking lot on the west side of the site at SW 25th St; 4) Revise the size and location of various planting beds and pavement areas; 5) Make various revisions to the materials used to construct the Gateway Monument signs at the north and south ends of the site; 6) Make minor revisions to the dimensions of the proposed shade arbors; 7) Revise the style/design of the proposed bike racks; and 8) Make minor revisions to the types and numbers of plants to be used in the Landscape Materials List.
